All entries for the Insurance Times Awards ("Awards") are subject to the following terms and conditions.

1. Entries must be submitted via the official entry system, which can be accessed at <https://www.eventsforce.net/itawards-22>
2. All Entries must be received by midnight, **Thursday 11th August 2022**, the Closing Date.
3. All Entries are accepted at our discretion; we reserve the right to refuse any Entry for any reason.
4. We do not accept responsibility for non-receipt or late receipt of entries. All submissions should receive an automated email confirming safe receipt. If you do not receive confirmation within 24 hours, please contact the events team at events@insurancetimes.uk.
5. By submitting your Entry, you agree that your entry and any information it contains can be used by us for any purpose whatsoever in connection with the Event.
6. Copyright of your Entry belongs to you, however by placing an Entry into the Awards, you grant Newsquest a worldwide royalty-free perpetual licence to edit, publish and use your Entry in any and all media (including print and online) for publicity and news purposes relating to the Event. Our right to publish details of your Entry includes, but is not limited to, editorial coverage and interviews in Insurance Times magazine and website and announcements at the Awards ceremony.

If you are called for the second stage of the judging process, you will be required to present (virtually) to our panel of judges on either 18th or 19th October (Note that if you are shortlisted in multiple categories you may be required both days). Further details regarding the date, time slot and expected content of your presentation will be sent out after the finalists are announced on 14th September. Please note that if you choose not to participate in the presentation, your entry will not be considered further.
13. Except in the case of manifest error, no correspondence will be entered into in respect of any Entry, finalists and/or winners of the Awards.
14. You agree to abide by the decision of the Judges' which shall be final and binding and no correspondence will be entered into.
15. In the event that you are a winner but are unable to attend the Awards ceremony, we reserve the right to charge for the winner's package (trophy, logo & certificate).
